CONDUCT POLICIES

A PROFESSIONAL RELATIONSHIP BETWEEN A TEACHER (OR TEACHING ASSISTANT) AND STUDENT SHOULD BE MAINTAINED AT ALL TIMES. ARRANGED CONTACT WITH STUDENTS OUTSIDE THE CLASSROOM IS INAPPROPRIATE AND THREATENS THE INTEGRITY OF THE TEACHER/ TA-PUPIL RELATIONSHIP. ALTHOUGH YOU MAY BE WELL-MEANING, IT IS NOT ALLOWED, EXCEPT IN EXTREMELY RARE CIRCUMSTANCES WITH THE APPROVAL OF THE ETHOS’ EXECUTIVE DIRECTOR AND THE STUDENT’S PARENT/GUARDIAN.

ALTHOUGH ETHOS HAS NEVER HAD A PROBLEM WITH THIS BEFORE, ETHOS IS EXTREMELY VIGILANT ABOUT ISSUES CONCERNING STUDENTS’ SAFETY. PHYSICAL CONTACT SHOULD BE KEPT TO AN ABSOLUTE MINIMUM, BECAUSE TOUCHING A STUDENT MAY BE INTERPRETED DIFFERENTLY THAN YOU INTENDED BY THE CHILD, HIS OR HER FAMILY OR BY OTHER STUDENTS. YOU MAY TOUCH A STUDENT’S HANDS FOR CORRECT HAND PLACEMENT ON THE MUSICAL INSTRUMENT YOU ARE TEACHING, BUT HUGGING AND OTHER FORMS OF PHYSICAL AFFECTION ARE INAPPROPRIATE AND SHOULD BE AVOIDED WHENEVER POSSIBLE. IN ADDITION, TAKE MEASURES TO ALLOW FOR AMPLE OVERSIGHT BY OTHER PEOPLE. FOR EXAMPLE, IF YOU ARE IN A SITUATION THAT REQUIRES YOU TO BE ALONE WITH A STUDENT, LEAVE THE DOOR OPEN.
